Hi Karen,

I hope you are well.

Our client has thrown a bit of a spanner in the works and wants all our works completed by close of Easter as they have people moving in and need the S278 complete (Something is was not aware of till this week).

I have run through our programme, and I think we can make that work subject to road space availability and your approval of course.

I have re-dated our TTRO (30mph) so that comes into force in December 2025. Not sure if you were made aware of this.

Our ideal plan if at possible would be as follows.

Commence works using some carriageway Incursion 5th January 2026 which will run through till 30th March 2026 and then we will erect 2 way traffic lights for the 2 weeks to complete our works.

We will however require some 2-way traffic lights in the middle of our permit to undertake some critical elements. I appreciate that we will be limited to School Holidays, so I was thinking of utilising the February Half Term, 14th→22nd February if available?

We also will need approx. 4 additional days of traffic lights at the start of our permit in January. Obviously this will be a little tricky. We can either work off peak only (09:30-15:00) or Saturday and Sundays over 2 weekends, which ever suits. I appreciate this is not helpful to you and challenging but I would really appreciate if somehow you could allow these lights for the isolated days.

Just for clarity I will list the requirements below.

- 5th January Some Carriageway Incursion (End 30th March)
- 10th & 11th January 2 Way Lights (or 4 days off peak in the week)
- > Continue with Some Carriageway Incursion only
- 17th & 18th January 2 Way Lights
- → Continue with Some Carriageway Incursion only
- 14th February 22nd February 2 Way Lights
- > Continue with Some Carriageway Incursion only
- 30th March 12th April 2 Way Lights and Works Complete.

We therefore would not need any further road space after the Easter Holidays.

If you would like to run through on teams to discuss or meet on site do let me know. Alternatively, if just you need any further information please do not hesitate to ask.

I look forward to hearing from you soon.
