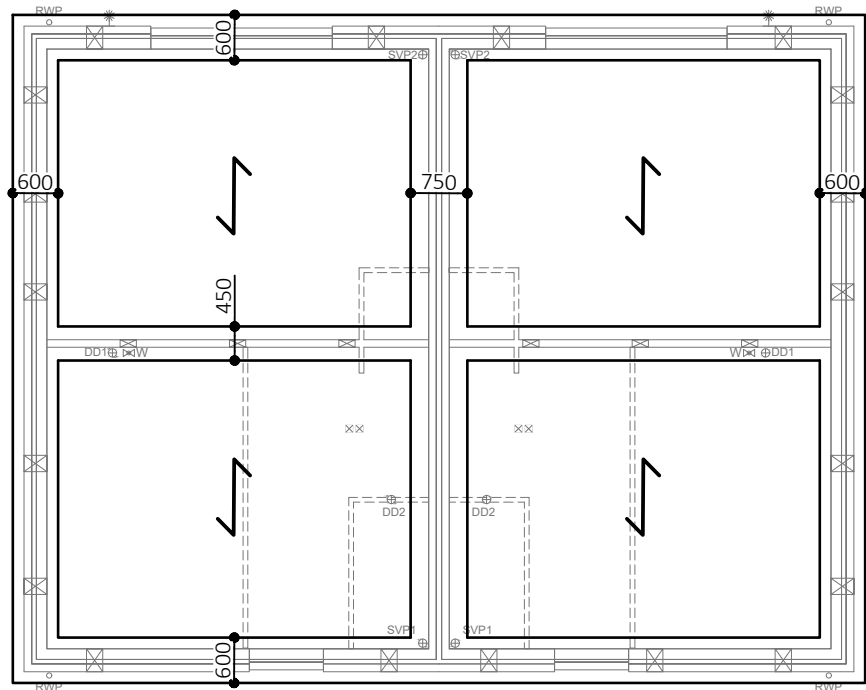
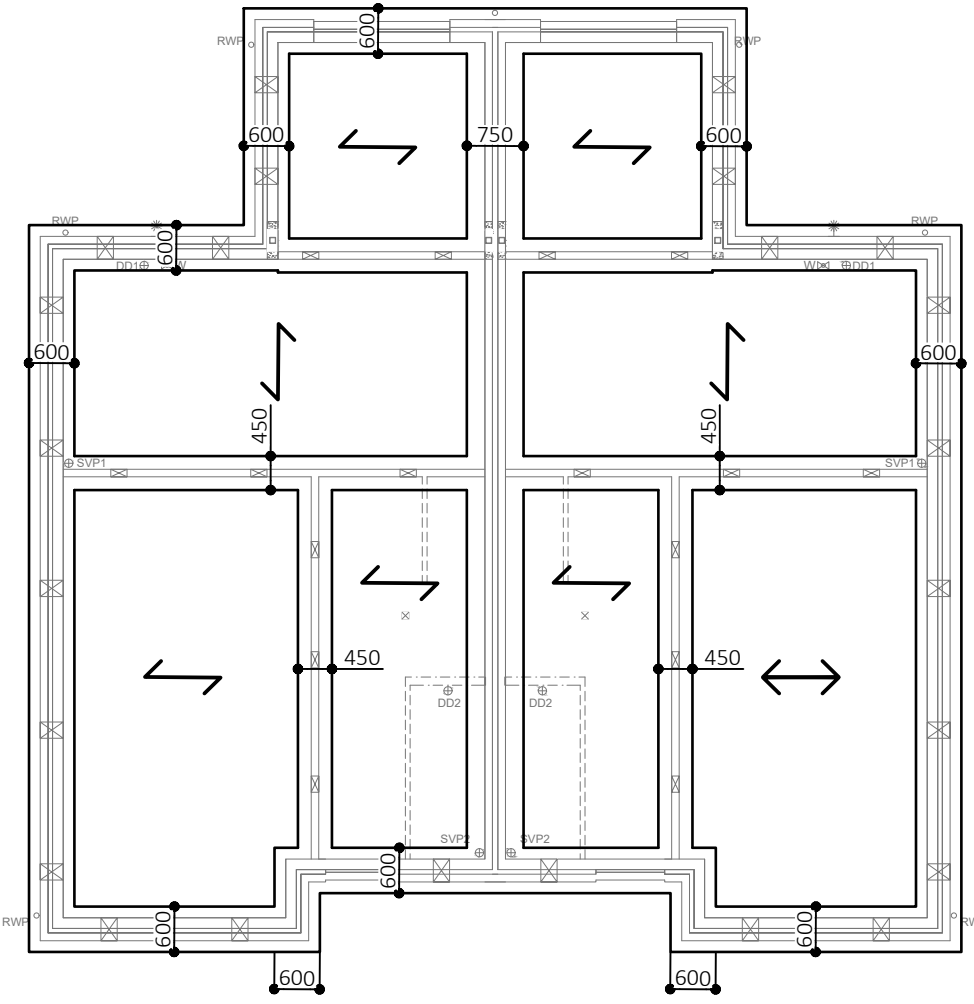
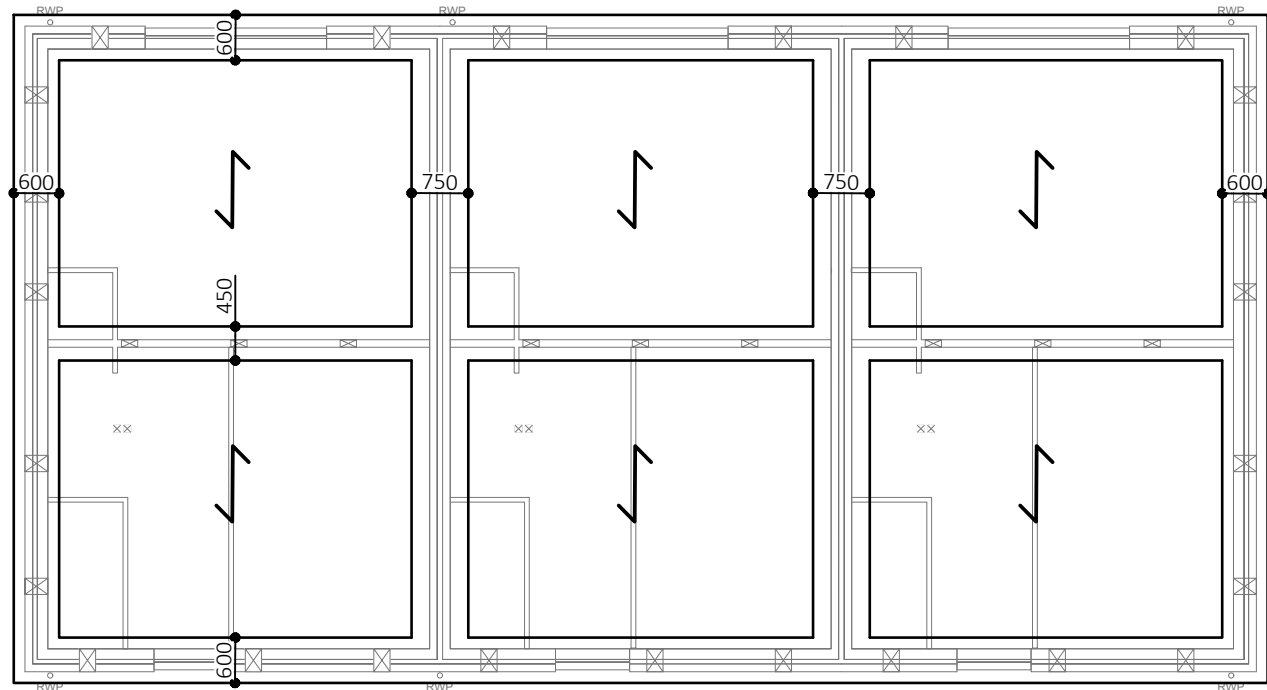




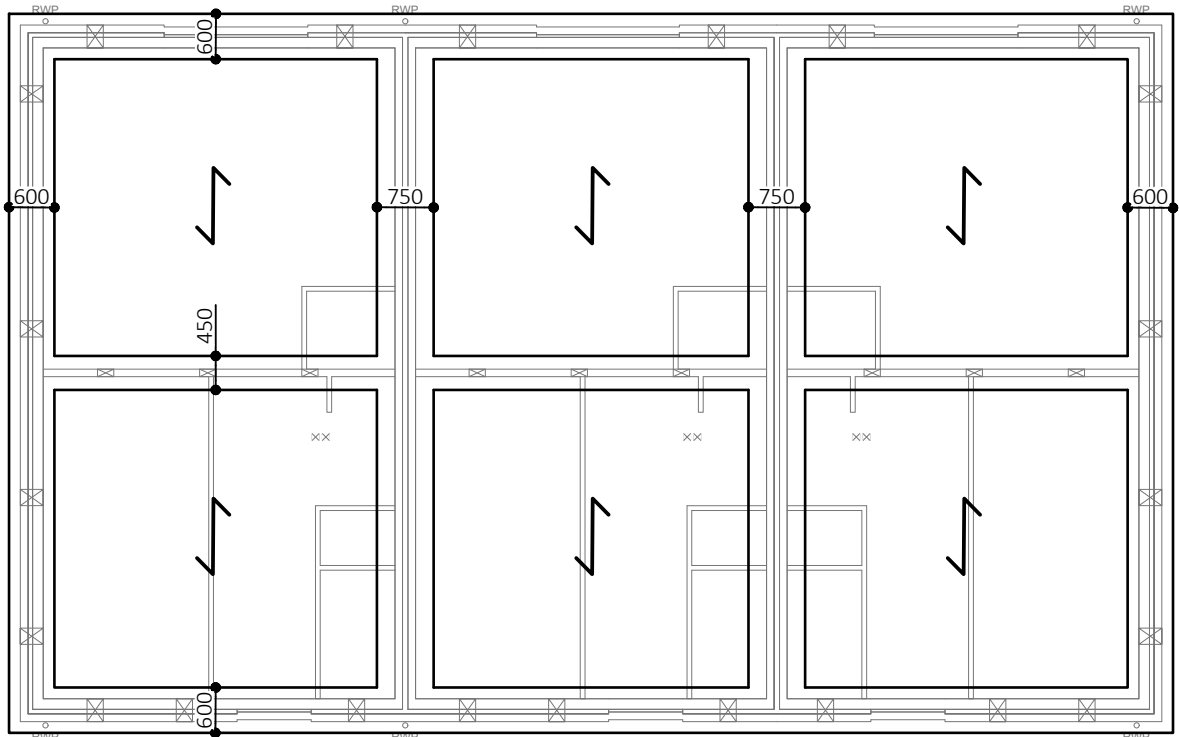
FOUNDATION LAYOUT HT BAYBERRY (2NO):

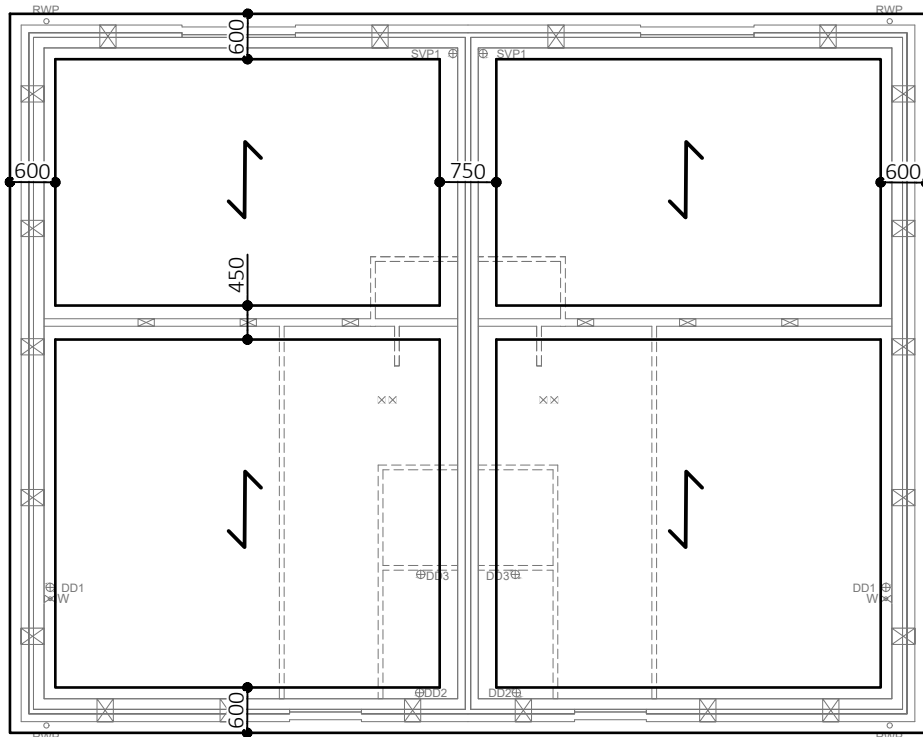
FOUNDATION LAYOUT HT FIR (2NO):

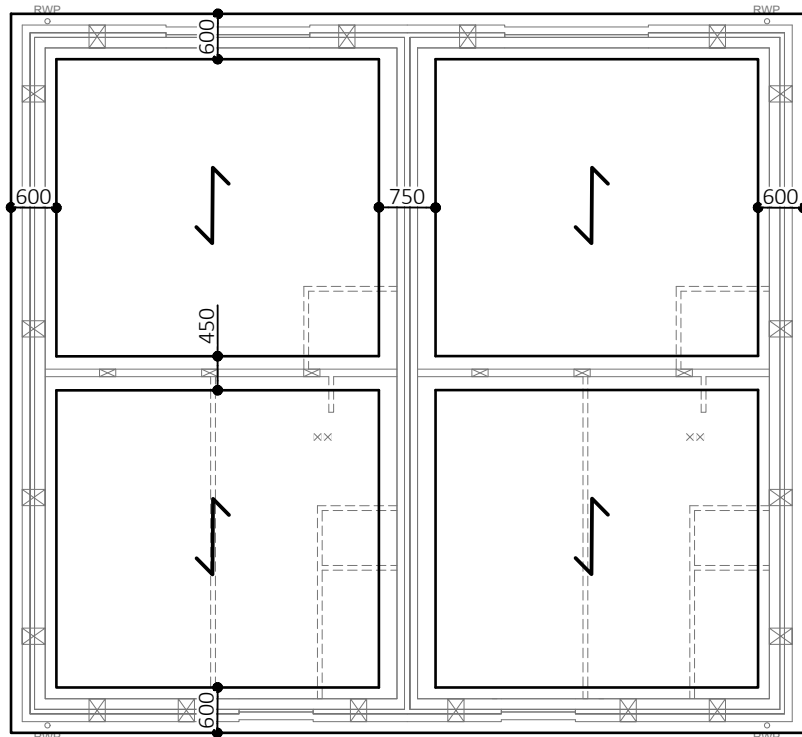
